ITEM #3: Comments Collected to Amend Regulation NAC 656.210:

On behalf of the Nevada Court Reporter's Association, Mary Cox Daniel stated the hardship in obtaining the Nevada law credits and submitted proposed language to remove the requirements and make it optional for certificate and license holders to earn these 2 credits. The committee replaced the words "must" and "may" with the word "shall" to offer parity throughout Chapter 656. The committee will present the amended language to the Board at their next scheduled open meeting for their review and approval before submitting to the Legislative Counsel Bureau for drafting. A copy of the proposed language is attached and will be kept on file. No further comments.

ITEM #4: Comments Collected to Amend Regulation NAC 656.320:

Peggy Elias submitted proposed language that will allow a Nevada court reporter the ability to provide court reporting services in any proceeding commenced or maintained in a foreign jurisdiction providing the Nevada court reporter complies with the rules and regulations of court reporting in this state. Sherrill Grotheer substantiated Ms. Elias' proposal by referring to the Uniform Interstate Depositions and Discovery Act adopted by the state of Nevada. The committee will present the amended language to the Board at their next scheduled open meeting for their review and approval before submitting to the Legislative Counsel Bureau for drafting. A copy of the proposed language is attached and will be kept on file. No further comments.
