ITEM #1: Meeting Called to Order:

Without motion, Dan Waite called the meeting to order at 5:32pm.

ITEM #2: <u>**Public Comments:**</u> Jason Makris announced he was in attendance to serve as a character witness for Gina Shrader, CCR #647, agenda item #6. No further comments.

ITEM #3: <u>Approval of the Agenda</u>:

MOTION made by Lori Judd: That the Board approves the agenda in its entirety. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

ITEM #4: Approve Meeting Minutes:

MOTION made by Lori Judd: That the Board approves the August 22, 2019 open meeting minutes in its entirety. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

MOTION by Lori Judd: That the Board approves the October 19, 2019 closed meeting minutes. Motion seconded by Lori Judd. Dan Waite, Heidi Konsten and Peggy Elias abstained; motion moves forward.

ITEM #5: <u>Settlement Agreement – Advanced Depositions, Firm #099F</u>: Advanced Depositions, Firm #099F was found in violation of failing to comply with the requirements of NAC 656.310; limitations on gifts and assessed an administrative fine of \$5,000.00 per violation. Advanced Depositions agreed to pay \$10,000.00 plus costs expended in this matter not to exceed \$500.00. A copy of the Settlement Agreement is attached and will be kept on file.

MOTION BY Peggy Elias: That the Board approves the settlement agreement as submitted and will be executed on November 14, 2019. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

ITEM #6: <u>Settlement Agreement – Gina Shrader, CCR #647</u>: Gina Shrader, CCR #647 was found in violation of failing to comply with the requirements of NRS 656.250; failure to provide transcripts in a timely manner and failure within a reasonable time to provide information requested by the Board as a result of a formal or informal complaint. Ms. Shrader was placed on a 1-year suspension, followed by 1 year of probation. Ms. Shrader agrees to pay the Board the amount expended for its attorney fees and costs and will have 1 year to pay such sum. Ms. Shrader is required to provide a list of outstanding transcript orders and she shall notify the Board within 24 hours of any new transcript order. While on suspension, Ms. Shrader shall not accept any new court reporting assignments.</u>

Jason C. Makris served as a character witness. He acknowledged Ms. Shrader's efforts in providing assistance in obtaining transcripts for his office and extended his appreciation to Ms. Shrader's dedication to the court reporting profession. No further comments.

MOTION by Peggy: That the Board approves the settlement agreement as submitted and will be executed on November 14, 2019. Motion seconded by Lori Judd, all in favor, motion moves forward.

ITEM #7: <u>Ratify October 19, 2019 Certification Exam Results:</u> Debbie Uehara reported 3 applicants registered for the October 19th exam. The exam ran smoothly. No incidents to report. After grading the exams, it was confirmed all 3 applicants passed the certification exam. No further comments.

MOTION by Peggy: That the Board approves the test results from the October 19, 2019 certification exam for court reporters. Motion seconded by Lori Judd, all in favor, motion moves forward.

ITEM #8: Proposed Disciplinary Procedures for NAC Chapter 656: Dan Waite presented proposed regulations that streamlines and provides clarification on the disciplinary process per NAC Chapter 656. Upon approval by the Board, the proposed language will be submitted to LCB for drafting. A copy of the proposed language is attached and will be kept on file.

MOTION by Lori Judd: That the Board approves the amended language outlined in NAC 656.035 and NAC 656.070. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approves the amended language outlined in NAC 656.420. Motion seconded by Lori Judd, all in favor, motion moves forward.

MOTION by Lori Judd: That the Board approves the amended language outlined in NAC 656.430. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

MOTION by Lori Judd: That the Board approves the amended language outlined in NAC 656.440 with the amendment to change the word "notice" to "notices" in subsection 5. Motion seconded by Heidi Konsten, all in favor, motion moves forward.

ITEM #9: <u>Proposed Citation Form for Unlicensed Practices</u>: Debbie Uehara shared NRS 656.300 allows the Board to issue a citation to a natural person or a business entity who is conducting court reporting services who has not been issued a certificate or a license. Ms. Uehara is asking the Board to determine the administrative fine when issuing the citation. No further comments.

MOTION by Peggy Elias: That the Board approve the form with the amendment to revise the header to read:

The State of Nevada Certified Court Reporters Board has the legal power and authority to take action against a natural person or a business entity who has violated any provision of the Nevada Revised Statutes (NRS), Chapter 656 or regulations set forth in the Nevada Administrative Code (NAC), Chapter 656.

Motion seconded by Heidi Konsten, all in favor, motion moves forward.

MOTION BY Heidi Konsten: That the Board establish a progressive fine for repeated offenses as listed below:

Fines for a natural person:

- \$150.00 First Offense
- \$300.00 Second Offense
- \$600.00 Third Offense

- \$300.00 First Offense
- \$600.00 Second Offense
- \$1,200.00 Third Offense
