### ITEM #3: <u>Approval of the Agenda:</u>

#### ITEM #5: <u>Amend Continuing Education Requirements Pursuant to NAC 656.210</u>:

MOTION by Severin Carlson: That pursuant to NAC 656.210(1), the Board will keep the requirements for a certificate holder and designated firm representative to earn at least 2 credits per reporting period that include a review of the court reporting statutes, regulations and court rules in this state. Motion seconded by Peggy Elias, all in favor, motion moves forward.

#### ITEM #6: <u>Amend Foreign Jurisdiction Procedures Pursuant to NAC 656.320</u>:

MOTION by Sherrill Grotheer: That the Board approves the proposed language in NAC 656.320 to allow a court reporter the ability to provide court reporting services in any proceeding commenced or maintained in a foreign jurisdiction providing the court reporter complies with the rules and regulations of court reporting in this state. Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

#### ITEM #7: <u>10 Year Review of Nevada Administrative Code Chapter 656:</u>

Upon completion of the 10 year review of the Nevada Administrative Code Chapter 656 conducted by the Legislative Regulations Committee, Peggy Elias and Sherrill Grotheer introduced amended and repealed language to the Board. The General Provisions and Disciplinary Procedure sections will be reviewed at a later date. A copy of the approved language in its entirety is attached and will be kept on file. Approved language will be submitted to the Legislative Counsel Bureau for drafting.

MOTION by Peggy Elias: That the Board approves the proposed language in NAC 656.180 with the amendment in subsection 2 to add the word "and" after the word "request". Motioned seconded by Severin Carlson, all in favor, motion moves forward.

MOTION by Severin Carlson: That the Board approves the proposed language in NAC 656.205. Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

MOTION by Sherrill Grotheer: That the Board approves the proposed language to apply the requirements of continuing education credits to a designated firm representative and replace the word "may" in subsection 3 to "shall". Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approves the proposed language in NAC 656.220. Motioned seconded by Severin Carlson, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approves the proposed language in NAC 656.230 and NAC 656.240. Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approves the proposed language in NAC 656.250. Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approves the proposed language in NAC 656.265 with the amendment to subsection 4 to insert a dash between 12 and month. Motion seconded by Peggy Hoogs, all in favor, motion moves forward.

MOTION by Peggy Elias: That the Board approve new language to apply the laws, rules, and regulations relating to the practice court reporting to court reporting firms in the same manner as the Board applies those laws, rules, and regulations to court reporters. Motion seconded by Sherrill Grotheer, all in favor, motion moves forward.

MOTION by Sherrill Grotheer: That the Board approves the proposed language in NAC 656.320 with the correction made in subsection 1 to replace the word "for" with the word "from" after the word "reporting". Motion seconded by Peggy Elias, all in favor, motion moves forward.

MOTION by Peggy Elias; That the Board approves the proposed language in NAC 656.330. Motion seconded by Severin Carlson, all in favor, motion moves forward.

MOTION by Sherrill Grotheer: That the Board approve the proposed language in NAC 656.350 with the amendment to subsection 2 to add the words "once the transcript has been certified" after the word "proceeding" and keep the word "and" in the after the word "alteration". Motion seconded by Peggy Hoogs, all in favor, motion moves forward.
