Dr. Cid requested additional time to complete the requirements for Licensure, as she was unable to complete in the 2 year time period, due to personal hardships. Dr. Young moved to extend to March 31, 2016. Ms. Becker second. Board Vote 5-0-0.

B. Desert Psychological; Accepting of Dr. Ahmad as a supervisor for Psychological Interns as well as clarification regarding the limits of supervisees within NAC 641.

Regarding the waiver to the physical presence of the supervisor, Dr. Lenkeit recommended to grant this waiver as we have in the past. Dr. Paul moved to approve and renew the training plan and to charge the subcommittee to review and evaluate the language change. The change to NAC 641.158© in the language accepted by the Board can be read as any combination of 5 psychological interns and assistants. The subcommittee will correct the language to limit to 3 psychological assistants and 2 psychological interns for a total of 5 supervisees.

The question asking clarification of time percentages for internship are actually in the regulations for psychological assistants. The subcommittee will evaluate NAC 641.080 and provide feedback to Board regarding changes needed for the regulation to better fit standards for internships.

In regard to the waiver of supervision requested for Dr. Ahmad to provide supervision prior to the three year licensure. Ms. Becker motioned to allow a waiver to Desert Psychological for the school year 2015-16 for Dr. Ahmad specifically to be able to provide a supervisory role, with less than 3 years of post-doctoral experience. The Board will further clarify this section of NAC for the future. Dr. Wood-Antonuccio second. Board Vote 5-0-0.
