**ITEM #4:** Disciplinary Hearing – State of Nevada Certified Court Reporters Board v. Rene Hannah, CCR #326: The Board reviewed all evidence filed against Rene Hannah, CCR #326 regarding her failure to transcribe and provide transcripts in a timely manner and her failure to store her notes in at least 2 formats and secure them against tampering or accidental destruction. Ms. Hannah received many requests from the court reporting firm to submit the transcripts; she failed to meet the deadlines and at times was not responsive. Ms. Hannah claims that she was experiencing technical issues with her equipment and suspected a person may have compromised her files while still accepting new jobs. Ms. Hannah confirmed that 2 of the 3 transcripts remain outstanding.

**MOTION by Severin Carlson:** That in accordance to NRS 622A.410, revokes Rene Hannah's certificate for a period of 18 months upon issuance of the order; after which time she may apply for reinstatement. If Ms. Hannah's certificate is reinstated after the 18 month period of revocation, she is subject to a 1 year probation period. Pursuant to NRS 622.400, Ms. Hannah is required to pay \$1,308.24 in attorney fees and costs to the Board within her 18 month revocation period. Motion seconded by Peggy Elias, Heidi Konsten abstained serving as the Board investigator, Lori Judd, Christine Alaimo in favor, motion moves forward.
