The purpose of the hearing is to receive comments from all interested persons regarding the adoption of permanent regulations outlined in R099-16 that pertain to chapter 656 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

The introduction of amendments will keep NAC Chapter 656 consistent with NRS Chapter 656 and will provide clarification to administrative duties, certification exam requirements, certificate and licensing requirements and disciplinary procedures.

- Revise provisions relating to examinations for certification as a court reporter.

- Revise provisions relating to disciplinary actions taken against court reporters and court reporting firms.
