ITEM #3: Approval of the Agenda:

MOTION by William LaBorde: That the Legislative Regulations Committee approves the agenda in its entirety. Motion seconded by Pauline May, all in favor, motion moves forward.

ITEM #4: Amend BDR for the 82<sup>nd</sup> Legislative Session Regulating Videographers: Peggy Elias presented the bill draft request regulating videographers and asked Debbie Uehara to review the motion made by the LVCC Committee to replace the word videographer with video recorder and videography with video recording throughout the bill. No further comments.

MOTION BY Pauline May: That the Legislative Regulations Committee approves the proposed bill and will present it to the Board for their review and approval. Motion seconded by William LaBorde, all in favor, motion moves forward.

BDR for the 82<sup>nd</sup> Legislative Session to Amend the Qualifications to take the Certification Exam: Peggy Elias presented a bill draft request for the 82<sup>nd</sup> Legislative Session to amend the qualifications to take the certification exam for a court reporter, specifically in NRS 656.170. A copy of the proposed language is attached and will be kept on file. No further comments.

MOTION by William LaBorde: That the Legislative Regulations Committee approves the proposed bill and will present it to the Board for their review and approval. Motion seconded by Pauline May, all in favor, motion moves forward.

ITEM #6: Amend LCB File No. R172-20: In keeping the language consistent, William LaBorde proposed replacing the word "deposition" with the word "proceeding" in Section 3, page 4. A discussion ensued to make additional changes to this section. Peggy Elias suggested to remove the mention of "video recording" since the Board does not regulate video recording. A copy of the amended language is attached and will be kept on file. No further comments.

MOTION by William LaBorde: That the Legislative Regulations Committee approves the amended language in R172-20, Section 3 and will present it to the Board for their review and approval. Motion seconded by Pauline May, all in favor, motion moves forward.

ITEM #7: <u>Amend NAC 656.261 and NAC 656.265 Regarding Exam Policies for the Firm Exam:</u>
Debbie Uehara presented proposed language outlining the deadlines, refund policy and extending the time period to grade the firm examinations. The proposed language mirrors the language for the certification exam for a court reporter. No further comments.

MOTION by Pauline May: That the Legislative Regulations Committee approves the proposed language that provides clarification for an applicant taking the firm exam. Motion seconded by William LaBorde, all in favor, motion moves forward.

ITEM #8: Military Reciprocity: Debbie Uehara presented a proposal to provide reciprocity to an active member of the Armed Forces, member's spouse, veteran or veteran's surviving spouse. NRS 622.510 and NRS 622.530 allows the Board to establish a regulation to provide reciprocity. Ms. Uehara provided proposed language from a previous 2013 bill draft request. Peggy Elias made amendments to the language; bringing it up to date. A copy of the proposed language is attached and will be kept on file. No further comments.

MOTION by Pauline May: That the Legislative Regulations Committee approves the proposed language and will present it to the Board for their review and approval. Motion seconded by William LaBorde, all in favor, motion moves forward.
