The introduction of R010-21 will require court reporting firms to place its name and the license number it received from the Board on certain correspondence to a court reporter or other court reporting firms, all invoices sent to a client, the cover page of all transcripts and on all advertisements for court reporting services in the state of Nevada. R010-21 will provide clarification to the public, court reporters and court reporting firm with whom they are conducting business when verifying their registration status with the Board.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
