The committee will prepare a proposal and present it to the Board for their review and approval. Each committee member was assigned to sections of Chapter 656 to review and make their recommendation to streamline, clarify, reduce or improve to ensure those regulations provide for the general welfare of the State without inhibiting economic growth.</u>
