ITEM #1: Meeting Called to Order:

Kevin Diamond called the meeting to order at 5:30pm.

ITEM #2: Public Comments: No public comments.

ITEM #3: Approval of the Agenda:

MOTION by William LaBorde: That the Legislative Regulations Committee approves the agenda in its entirety. Motion seconded by Pauline May, all in favor, motion moves forward.

ITEM #4: **Review Proposed Language for a Certificate by Endorsement:** Lori Judd shared the history, dating back to 2010, on the reasons of formulating language for a certificate by endorsement. Pauline May shared there were concerns from the previous committee meeting that the proposed language did not provide an alternative means for an applicant to seek reciprocity. The proposed language duplicates the same requirements for an applicant to seek certification and does not provide the privileges of reciprocity. A discussion ensued regarding the requirements from other states and their interpretation of court reporting. No further comments.

Motion by Kevin Diamond: That the Legislative Regulations Committee approves the proposed language for a certificate by endorsement with the following amendments:

- Section 1(c)(1): Remove the word or after the semicolon.
- Section 1(c)(2): Remove the period and replace with a semicolon and add the word or.
- Create a new section, Section 1(c)(3): A corresponding valid and unrestricted license as a court reporter or voice writer in a jurisdiction in the District of Columbia or any state or territory of the United States that is substantially equivalent.
- Section 3 and 4: Delete
- Section 5 now becomes Section 3

Motion seconded by Lori Judd, all in favor, motion moves forward.

Motion by Kevin Diamond: That the Legislative Regulations Committee amend their previous motion and include the following change:

Section 1: Change the last sentence to read "...NRS 656.150, NRS 656.180 and NAC 656.150.

Motion was seconded by William LaBorde, all in favor, motion moves forward.

ITEM #5: **Review Proposed Language for Unlicensed Practices:** William LaBorde presented a new regulation relating to unlicensed practices. He felt this proposed language was in line to Senator Daly's suggestion to protect the public from unlicensed practices. The language is presented as a regulation which would not require a sponsor and could also be presented as a bill draft request that requires a sponsor. It was discussed to seek the guidance of Senator Daly on the best course of action. No further comments.

Motion by Kevin Diamond: That the Legislative Regulations Committee approves the language for unlicensed practices with the following amendments:

- Section 5: replace the word prefer with the word proffer.

Motion seconded by Pauline May, all in favor, motion moves forward.

ITEM #6: **Next Meeting Date and Agenda Items:** Kevin Diamond requested to schedule the next committee meeting after representatives meet with Senator Daly to discuss new language. The meeting date and agenda items will be determined at a later date. No further comments.
