## ITEM #5: Discussion to Amend R193-22 Relating to Third Party Transcript Requests:

MOTION by Peggy Elias: That the Legislative Regulations Committee assign Kevin Diamond and William LaBorde to amend Section 4 of LCB File No. R193-22 relating to third party transcript requests. The proposed language will be presented and reviewed at the next scheduled committee meeting. Motion seconded by Lori Judd, all in favor, motion moves forward.

- ITEM #6: Keeping NRS 3.370 Consistent with NAC Chapter 656: Kim Farkas, CCR #741 offered the services of the Nevada Court Reporters Association's lobbyist to introduce amendments to NRS 3.370 at the 2025 Legislative Session. Currently, NRS 3.370 and NAC Chapter 656 transcript formats are not consistent. A discussion ensued and without motion, it was determined to submit amendments to NRS 3.370 to keep it consistent with NAC Chapter 656. Ms. Farkas will present the amendments to the lobbyist. A copy of the proposed language is attached and will be presented to the Board for their review and approval. No further comments.
- **ITEM #7:** Formulate a Regulation for a Certificate by Endorsement: Pursuant to NRS 622.530, a regulatory body must adopt regulations for a certificate by endorsement for qualified persons. The original proposed language was outdated and rejected by LCB. The committee assigned members to conduct further research and formulate new language. No further comments.

MOTION by Kevin Diamond: That the Legislative Regulations Committee assigned Lori Judd and Pauline May to conduct further research and formulate language for a certificate of endorsement. The proposed language will be presented and reviewed at the next scheduled committee meeting. Motion seconded by William LaBorde, all in favor, motion moves forward.

**ITEM #8:** <u>Regulation for Zoom Depositions</u>: Peggy Elias presented proposed language relating to remote proceedings. The proposed language will provide clarification to court reporters and court reporting firms. A copy of the language is attached and will be presented to the Board at a future open meeting for their review and approval. No further comments.
