**ITEM #3: Approval of the Agenda:**

MOTION by William LaBorde: That the Legislative Regulations Committee approves the agenda in its entirety. Motion seconded by Pauline May, all in favor, motion moves forward.

**ITEM #4:** **Review Proposed Language for R193-22 Relating to Third Party Transcript Requests:** Kevin Diamond presented proposed language, specifically for Section 4 for LCB File No. R193-22. A copy is attached and will be kept on file. Peggy Elias submitted several amendments for the committee to consider. A discussion ensued and the following motions were made for each paragraph. No further comments.

Motion by Kevin Diamond: That the Legislative Regulations Committee approves the proposed language in Sec 4.1 with the amendment in sentence #1 to read "...copy of the transcript of a deposition..." and sentence #2 will be deleted. Motion seconded by Peggy Elias, all in favor, motion moves forward.

Motion by Peggy Elias: That the Legislative Regulations Committee delete paragraph 3 of the proposed language. Motion seconded by Pauline May, Kevin Diamond opposed, all others approve. Motion moves forward.

Motion by William LaBorde: That the Legislative Regulations Committee change paragraph 4 to become paragraph 3 and it shall read "...upon receipt of payment of the current copy rate provide a copy of the requested transcript of the deposition to the third-party requester. Motion seconded by Pauline May, all in favor, motion moves forward.

**ITEM #5:** **Review Proposed Language for a Certificate by Endorsement:** Pauline May presented the proposed language formulated by herself and Lori Judd, a copy is attached and will be kept on file. Peggy Elias stated the proposed language mirrors our current statutes (requirements) for certification and it did not provide the privileges of reciprocity. William LaBorde suggested to include the language in NRS 622.530 that outlines the requirements of reciprocity. Debbie Uehara stated it was not necessary to include NRS 622.530 since it is the authority for the new regulation. Lori Judd was not present at this meeting. Kevin Diamond wanted to hear Ms. Judd's comments before taking action on the proposed language. He requested to table this agenda item for a future committee meeting. No further comments.

Motion by Peggy Elias: That the Legislative Regulations Committee move this agenda item to the next scheduled committee to seek Lori Judd's comments. Motion seconded by William LaBorde, all in favor, motion moves forward.
